- It was decided to adopt adequate measures to improve the strength of the alumni association in the college. It was proposed to organise 'Batch-meet'get-togethers and important measures for raising funds will be undertaken.
- Proposal for alternative e-waste management measures will be submitted by IQAC.
- Two workshops on subject-specific novel teaching pedagogies will be organized by IQAC. Subject experts will be invited for this purpose.
- A proposal for initiating a social media page preferably on Instagram or Facebook will be made. This will make the process of bio-data updation and other activities easier.
- It was decided that all grievances raised on Sampark, grievance redressal cell and RTI's
 will be addressed in the Action Taken Report of the college. The ATR will include
 consideration of the afore-mentioned sources apart from the feedback reports and needbased surveys.
